During the program, the Honorable Minister appreciated the India Food Expo organized by IIA and visited more than 100 stalls established in the exhibition and in the inauguration ceremony of the exhibition, the Industry Minister said that today the industrial environment in the state is much better than the situation before the year 2017. has improved. Record investment has been received in the state and the state government is ready to solve the problems of entrepreneurs. In his address, the industries minister assured that effective action will be taken on the problems and suggestions presented by the National President IIA and Chairman of the Food Processing Committee.



National President Neeraj Singhal in his address said that for the first time this year, 5 countries China, Vietnam, Uganda, Uzbekistan and Rwanda have set up stalls related to food processing industries in the India Food Expo, out of which Vietnam has come to the India Food Expo for the first time. Participating as a country partner. Apart from this, more than 100 renowned companies from across the country are exhibiting their products, machinery and technology in the expo. He presented various industrial problems and suggestions before the Industries Minister, in which the main proposal was to change the industrial land from lease hold to free hold and problems related to market fees.

National General Secretary Alok Aggarwal said that in the 03day exhibition, information about import-export opportunities will be given in the one-day national seminar to be held on 02 December 2023, in which technical sessions will be given by high officials of Vietnamese Embassy Trade Office and other institutions. Appropriate advice will also be given to guide the participants and new opportunities will





MSME entrepreneurs to set up food processing industries. For the first time, a national seminar for prospective entrepreneurs will be provided at the India Food Expo to provide important



information for starting a franchise business.

Chairman of IIA Food Processing **Industry Committee** and coordinator of India Food Expo, Deepak Bajaj, while conducting the program of the inauguration ceremony, informed Nand Gopal Gupta (Nandi) about the practical problems faced by the farmers

of the state in selling their products to food processing industries and Said that although the state government has given exemption from market fee for purchasing their produce directly from the farmers, but the farmers and food processing industries of the state are not getting its benefit because if the farmer wants to sell his produce directly, then the market To get exemption from fee, it has been made mandatory for him to provide his land records. Deepak Bajaj urged the Industries Minister that since farmers do not want to give their land records and small farmers want to receive cash payment, both these conditions should be repealed.

On the inaugural occasion of the Food Expo, the vote of thanks on behalf of IIA was given by Senior Vice President Dinesh Goval. On this occasion, IIA Treasurer Awadhesh Aggarwal, former President of IIA, various officials and more than 100 entrepreneurs were present.

National Seminar on Food Processing Industry – 2nd December'23

On the second day of the expo, a National Seminar On Food Processing Industries was organized today, 2 December 2023. This seminar was inaugurated by Shri Manoj Kumar Singh IAS, Agriculture Production Commissioner and IIDC in Uttar Pradesh Government. The High Commissioner of Uganda, Her Excellency Professor Joice Kikafanda was present as the special guest at the inauguration ceremony along with Dr. Atul Singh Director Horticulture & Food Processing.

In his address at the seminar, National President Neeraj Singhal said that on the call of IIA, during the Global Investor Summit in the state, a large number of IIA members have signed MOUs for investment and have also given applications for issuing letters of comfort. Most of these applications relate to food processing industries which have not yet received the Letter of Comfort. In Bareilly division alone, proposals of about 46 entrepreneurs worth about Rs 300 crore are still pending. If letters of comfort are received then these small scale industries will be established soon. Along with this, the National President also made the participants aware about the Industry Health Card Scheme, Senior Expert Services and the scheme to prepare MSMEs for Industry 4.0 launched by IIA for the entrepreneurs of the state and called upon them to do more and more. Entrepreneurs can take advantage of these schemes of IIA to make their industry competitive. The National President also presented several other proposals for the upliftment of the industries in the state before the IDC and Agricultural Production Commissioner, Uttar Pradesh, which also includes the proposal to make lease hold industrial land free hold. National President Neeraj Singhal urged the students present in the seminar from various educational institutions to dream



big and start their own startup from small business and if they keep working hard, one day they will become big entrepreneurs. Chairman of Food Committee of IIA, Shri Deepak Bajaj said that for the first time this year, stalls related to food processing industries have been set up by 5 countries China, Vietnam, Uganda, Uzbekistan and Rwanda in India Food Expo. Shri Bajaj gaid that although the state government has given exemption in

Shri Bajaj said that although the state government has given exemption in market fee on the products purchased by industries from farmers, which has been welcomed by IIA, there are procedural problems in its implementation which need to be resolved.

Agricultural Production Commissioner and IIDC Mr. Manoj Kumar Singh IAS said in his presidential address that the process of giving letters of comfort for the proposals submitted by the investors in the state is going on continuously and soon the remaining proposals will also be disposed of. On industries and farmers not getting the benefit of exemption in market fees, the Agriculture



Production Commissioner said that efforts are being made to find a solution by reconsidering the scheme.
